Detail may not add to total because of rounding. Some trend shifts are related to institutional reclassification. For example, beginning in FY 1978, two laboratories that were formerly considered academically administered federally funded research and development centers became part of their respective institutions: the Applied Physics Laboratory (Johns Hopkins University) and the Applied Research Laboratory (Pennsylvania State University). Data for these laboratories are included in academic figures beginning in FY 1978. Similarly, Draper Laboratories separated from the Massachusetts Institute of Technology as of FY 1974 to become an independent nonprofit institution; data for this laboratory are included in the Massachusetts Institute of Technology's figures prior to FY 1974. For the FY 2020 survey, DOD S&E support to higher education institutions and DOD R&D support to nonprofit organizations are known to be understated. However, the magnitude of the missing data is unknown. Data users should use caution when conducting any time series analysis that includes DOD obligations data for FY 2020.
